[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Deputy Sheriff Royce Brooks, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since March 2017. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant being duly sworn states as follows:

On 6/23/19, your Affiant attempted to conduct a traffic stop on a 2004 Honda bearing Florida registration 2618VP, in which Irvin ARIAS MARQUEZ (Defendant) was the driver for a violation of Florida State Statute 320.261.

Your Affiant activated the lights on his marked OCSO patrol vehicle to conduct a traffic stop. The Honda continued traveling south on Eglin Parkway at which time your Affiant gave several siren chirps. The Honda turned onto Second Avenue and began speeding away attempting to elude your Affiant. During the pursuit the Honda traveled in excess of 70 miles an hour through residential neighborhoods with no regards for the safety of others, running numerous stop signs. Due to the high speeds the Defendant failed to navigate a turn at James Lee Road and Pocahontas, causing the Honda to leave the roadway and nearly strike a brick wall. Your Affiant positioned his patrol vehicle directly behind the Honda, exited his patrol vehicle and gave the Defendant verbal commands to exit the Honda. The Defendant put the Honda in reverse and intentionally struck your Affiant's patrol vehicle and again began to flee. The Defendant continued to flee, crossing through several residential yards. As the Defendant was fleeing down Pelham Road he was observed tossing multiple beer bottles out the window.

The Defendant failed to stop for the red light at Pelham Road and Beal Parkway, striking another motorist causing injuries to the motorist. After striking the vehicle the Defendant continued fleeing south on Beal Parkway. The Defendant turned onto Gap Creek Drive and slowed its speed to an estimated 5 miles per hour. The Defendant opened the door, jumped out and began fleeing on foot through the yard of 615 Gap Creek Drive.

Once on foot, the Defendant entered a house and later exited through a window. After a short foot pursuit the Defendant was taken into custody.

After being taken into custody, the Defendant was observed to be unsteady on his feet and needed assistance walking to the patrol car. The Defendants speech was slowed and the odor of an alcoholic beverage was emitting from the breath as he was speaking.

During a post Miranda interview, the Defendant refused to answer questions.

During a query of the Defendants driving history it was discovered his driver's license was suspended. This was confirmed by OCSO Dispatch via NCIC query.

During an inventory of the Honda a clear plastic bag containing suspected cocaine was located in the driver side door. The Suspected cocaine was field tested and results were positive for cocaine.

Based on the above, your Affiant has probable cause to believe Irvin ARIAS MARQUEZ did violate Florida State Statute 316.1935.3a: Flee with disregard for safety, 893.13.6a: Possession of cocaine, 316.027.2a: Hit and run involving injury, 316.192.3a1: Reckless driving with damage to property/ person, 316.193.1: DUI, and 322.34.10b1: DWLSR.
