On May 24, 2019, the Defendant Marqus Ladon Demons violated F.S.S 812.13.2(a) by committing the offense of Robbery with a Firearm.

The Victim Rodney Rankins stated in a sworn written Affidavit that while he was at the Tom Thumb Store, located at 1101 Eglin Pkwy, Shalimar, FL, a black male, later identified as the Defendant Demons through a photo array, asked him if he could get a ride to the Burger King. While driving him to Burger King, Defendant Demons told Rankins to drop him off near a business on 3rd Street, Shalimar, because he had a friend who lived nearby. Rankin pulled into the back parking lot, at which time, Defendant Demons pulled out a hand gun and told Rankin to give him all his money. Rankin told defendant Demons that all he had was eleven dollars and to take it. Defendant Demons replied "I will shoot you right now" but was interrupted when a witness came outside and fled without taking the eleven dollars.

This was witnessed by Brandy Laws who stated: she heard two males yelling at each other outside of her office window. Upon stepping outside the victim yelled at her that he was being robbed and to call the police. Defendant Demons ran off.

The Defendant Marqus Demons location is unknown.

Demons was captured on nearby video surveillance running away from the scene.

Based on the above stated facts I have reason to believe and do believe the Defendant Marqus Ladon Demons violated Florida State Statutes 812.13.2 (a). This offense occurred in Okaloosa County where I am a sworn Investigator with the Office of the Sheriff."
