[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Wednesday, June 5, 2019 at approximately 0525 hour, the DEFENDANT, Amanda Kay Hunter (W/F DOB 08-15-1985) did knowingly and willfully commit the offenses of three (3) counts Uttering Forged Instruments and one (1) count Grand Theft.

The DEFENDANT misrepresented herself as the VICTIM, Kelly M. Desoto (W/F DOB utilized the VICTIM's debit card for the purchase. The transaction was declined, however then the DEFENDANT passed one (1) of the VICTIM's personal checks, check number 0651, without the authorization of the VICTIM. The purchase was approved for the total amount of \$433.46.

The DEFENDANT then walked to the front of the store and proceeded to the cash register to check out for a

second time. The DEFENDANT purchased more items and passed a second check, check number 0652, which belonged to the VICTIM without the VICTIM's authorization. The purchase was approved for the total amount of \$201.25.

The DEFENDANT deprived the victim out of a total of \$634.71.

This charge is supported by Walmart in-store video surveillance of the DEFENDANT making both purchases. This charge is also supported by sworn Affidavit by the VICTIM in reference to the fraudulent use of both the credit card and the two (2) checks.

Your Affiant has reason to believe and does believe the DEFENDANT, Amanda Kay Hunter (W/F DOB 08-15-1985) did commit the unlawful offense of Uttering Forged Instruments, pursuant to F.S.S. 831.02 and Grand Theft, pursuant to F.S.S. 812.014(2)(c).

The offense did occur within Okaloosa County, Florida, where I am a Sworn Law Enforcement Officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 5, 2019, the Defendant, Derek Shannon Nielsen, was found to have been driving while license suspended, grand theft auto, fleeing and eluding Law Enforcement Officer, resisting without violence, leaving the scene of a traffic accident with property damage, and possession of controlled substances, to whit:

On the above date, the Defendant was observed driving a black 2013 GMC Denali bearing a Tennessee tag # EP3837 in the area of Mesa Road in Destin, Florida. This vehicle matched the description of one involved in multiple crimes in Okaloosa County. While attempting to obtain information on the tag, the vehicle immediately fled and a vehicle pursuit ensued. In the course of this pursuit multiple marked Okaloosa County Sheriff's Office vehicle were attempting to stop the vehicle utilizing emergency lights and sirens.

The pursuit ended when the GMC crashed into a tree on Sandalwood Court. The Defendant bailed from the drivers seat and attempted to flee on foot. Due to the heavy presence of law enforcement officers in the area, the Defendant was immediately captured on Sandalwood Drive. Search incident to arrest, the Defendant had in his front pants pocket a tightly wrapped plastic bag which contained two jewelry bags. One bag contained a crystal like substance which had the characteristics of methamphetamine and the second containing a brown like substance which had the characteristics of heroin. The Defendant initially failed to identify himself and had no identification on his person.

Post Miranda, the Defendant invoked his rights to remain silent.

The crystal and brown substances were field tested. The crystal like substance tested presumptive positive for methamphetamine and the brown substance tested presumptive positive for heroin. The approximate weight for both items were less than a gram.

The Defendants Florida drivers license # N425177920820 was suspended as of 5/22/2017. The GMC, VIN # 1GKKVTKD2DJ185295 was stolen out of Walton County, Florida.
