[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 30, 2019, I investigated an armed robbery which occurred at the intersection of Hardie Lane and Anderson Dr., Fort Walton Beach, Florida.

The victim, Dennis Foster, stated that a black male with short hair, no shirt, wearing black nylon pants came up and asked him if he would like to buy narcotics. Dennis said he refused the narcotics, at which point the aforementioned black male asked for his bag. The victim's bag contained a smart phone valued at \$140.00, a jewelry box with Marilyn Monroe's photo on it, a brass cross, a debit card and \$11.00 in US currency.

When Dennis refused to hand over his bag, the black male brandished a silver handgun and pointed it at him and took the bag. The victim stated he handed over his bag because he was in fear for life and thought he was going to be shot. The victim described the defendant as a black male with tattoos from his left collar bone to his right collar bone who had a muscular build.

During a canvass search of the area, a third party witness, who was given a description of the suspect, claimed to have seen him in the area on a black bicycle.

Shortly thereafter, a black bicycle was located sitting against a trash can at 24 Hardie Lane. Aback male subject who matched the description of the suspect was located at 24 Hardie Lane, sitting at the rear of the lot. Based on the aforementioned black male matching the description of the suspect, he was detained pending a show up.

The victim positively identified the black male as the individual who robbed him. The victim said he knew this was the person who robbed him because of the defendant's physical appearance, tattoos and muscular build. The victim also mentioned that he personally knew the defendant from previous narcotics transactions where he bought illegal narcotics from the defendant.

During a post Miranda interview with the defendant, who was identified as Avlin Lattrail Williams, he denied any involvement in this offense. The defendant stated he knew the victim, but only from seeing him in the neighborhood.

A subsequent search was executed at 24 Hardie Ln. During the search, a firearm was located matching the description given by the victim.

Based on the results my investigation, the defendant Alvin Williams is in violation of F.S.S. 812.13.2 (a) Robbery with a firearm and F.S.S 812.014.3 (a) Larceny
