[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Your affiant has reason to believe the defendant (Elizabeth Hallford) committed the offense of Escape.

On July 25, 2019, the defendant was sentenced to five years' incarceration at the Department of Corrections.

Upon sentencing, the defendant was taken into custody, fingerprinted, and placed in the secure hallway adjacent to the courtroom awaiting transportation to the county jail.

It was during this time, the defendant found an unsecured door and escaped the secure area and subsequently fled courthouse property.

Video evidence exists which shows the defendant commit the aforementioned act.

The defendant was recaptured approximately two blocks away from the courthouse within minutes of her escape.
