#### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Deputy Sheriff Matthew Langer, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since January 2017. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant being duly sworn states as follows:

On July 30, 2019, your Affiant was conducting patrol operations in the area of James Lee Boulevard and Gerold Street, Fort Walton Beach, Okaloosa County, Florida.

While conducting patrol operations, your Affiant observed a white 2017 Nissan, bearing Florida registration 510TZI traveling northbound on James Lee Boulevard. As the Nissan turned onto Gerold Street and began traveling eastbound, your Affiant observed a black male later identified as Timothy WRIGHT (Co-Defendant) within the Nissan. After losing sight of the Nissan, your Affiant learned the Nissan was stolen out of Okaloosa County, Florida, during a registration query.

A short time later Deputy Sheriff Royce Brooks observed the Nissan traveling southbound on Beal Parkway as it passed Pelham Road, Fort Walton Beach. While Deputy Sheriff Royce Brooks attempted to catch up to the Nissan, the Nissan turned onto Park Drive, and Deputy Sheriff Brooks lost sight of the vehicle.

During a canvass of the area, your Affiant viewed the Nissan parked at 616 Gap Creek Drive, Fort Walton Beach. As deputies approached the Nissan, it was determined to be unoccupied.

Simutaineously, Sergeant Kyle Lowrey and Deputy Sheriff Brooks located Jaheim STANLEY (Defendant) and WRIGHT walking away from the area of the Nissan and were subsequently detained.

Post Miranda, STANLEY stated he was picked up by his friend in the Nissan and the friend allowed him to drive. While driving the Nissan, STANLEY became aware of it being stolen, but continued to drive it to the aforementioned location. STANLEY refused to provide a name for the other occupants within the Nissan.

Post Miranda, WRIGHT stated he requested a ride home from STANLEY and was picked up at the Tom Thumb, located at 609 James Lee Road, Fort Walton Beach, while STANLEY was operating the Nissan. While traveling within the Nissan, WRIGHT learned the Nissan was stolen and stated he requested to get out of the Nissan, but STANLEY continued driving.

NOTE: WRIGHT resides approximately 0.3 miles away from the above listed Tom Thumb. When your Affiant first viewed the Nissan, it was traveling in the opposite direction of WRIGHT's residence.

A short time later, Deputy Sheriff Tony Wilhelm made contact with Donald GATES (Co-Defendant) who was located a short distance from where deputies made contact with STANLEY and WRIGHT.

Post Miranda, GATES stated he stole the Nissan from Destin, Florida, in the early morning hours of July 30, 2019. GATES stated at 1900 hours on July 30, 2019, he picked up STANLEY and WRIGHT from 609 James Lee Road, Fort Walton Beach, and allowed STANLEY drive. GATES stated he believed both STANLEY and WRIGHT knew the Nissan was stolen when your Affiant was originally behind them on James Lee Boulevard.

Based on the above, your Affiant has probable cause to believe Timothy WRIGHT did violate Florida State Statute 812.014.2c6: Grand Theft of a Motor Vehicle. The minor was NOT offered a diversion program in keeping with agency directive.
