



[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On August 1, 2019, the Okaloosa County Sheriff's Office Narcotics Unit conducted a narcotics search warrant at  Crestview, Florida. A recreational vehicle (RV) on the property was secured and the following subjects were detained: ELIZABETH ANN EDGE, Devon Boles, and Colby Hart.

Upon execution of the search warrant, five children  were discovered inside the main residence  Chelsea Leann Howell. All of the children had visible dirt staining on

their skin and did not appear to have been bathed recently. Investigators observed deplorable conditions throughout the home to include the following:

Trash strewn about in every room
Dirty clothing on the floor throughout the home
Decaying food matter throughout the home
Roaches in various stages of development throughout the home
Fecal matter smeared across an appliance
Rat droppings throughout the kitchen including the food preparation area
Rotten food inside the refrigerator and throughout the kitchen

A pungent and acrid aroma filled the home indicating that the filthy conditions listed above are not a recent phenomenon.

Investigation revealed [REDACTED] Howell, has been living in the home with [REDACTED] since the fall of 2018 and the conditions were similar at that time. Currently, only Howell and [REDACTED] where the above observations were made. However, investigators found EDGE had been aware of the living conditions in the home since September 2018, and that EDGE failed to report the conditions to proper authorities.

The Florida Department of Children and Families removed the children from the home for safety reasons.

A search of the RV, where EDGE lives alone, revealed suspected methamphetamine in multiple locations, glass smoking devices and digital scales.

Investigation revealed EDGE had distributed methamphetamine to Boles, from the RV, as recent as just prior to our arrival. This substance was recovered and field tested positive for the presence of methamphetamine. A sample of residue from one of the glass smoking devices was field tested and provided a presumptive positive result for the presence of methamphetamine. It should be noted, [REDACTED] is within 300 feet of Victory Baptist Church.

Based upon the aforementioned information, Investigator Richards have reason to believe and do believe that ELIZABETH ANN EDGE violated FSS 893.13.1e1 Possession of a Controlled Substance Intent to Distribute within 1000 Feet of a Place of Worship, FSS 893.147 Possession of Paraphernalia, and FSS 39.205.1 Failure to Report Child Neglect (5 counts).
