[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On July 31, 2019 Thomas Dehart did violate F.S.S. 843.08 Impersonate Law Enforcement.

On the above mentioned date, Dehart did tailgate another vehicle, eastbound on Emerald Coast Parkway, Destin, FL. While behind the vehicle, Dehart did activate flashing, blue LED lights installed on the headlights of the vehicle, a black Chevrolet bearing AL tag 8195AZ4. Dehart then pulled up beside the other vehicle and flashed his open wallet at the occupants thru his passenger window pointing towards it. These actions did make the occupants of the other vehicle think Dehart was acting as a law enforcement officer.

The LED lights are controlled by an application on Dehart's phone, which were powered on in solid red mode upon law enforcement contact. Furthermore, Dehart's wallet was observed on the front passenger seat, which matched the description provided by the witness.

Based on the above information I have reason to believe, and do believe, Thomas Dehart did violate F.S.S. 843.08 Impersonate Law Enforcement. This offense did occur in Okaloosa County where your affiant is a sworn law enforcement officer.
