[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Deputy Sheriff Colin Savoie, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since August 2018. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant being duly sworn states as follows:

On 08/12/2019 your Affiant and Deputy Piaget responded to 471 Mary Esther Blvd. (The Sonic Drive-In Restaurant) in reference to a welfare check on an individual reported to be slumped over in the driver's seat of a vehicle and unresponsive.

Upon making contact with the Defendant, your Affiant observed the Defendant to be slumped over as described. The Defendant awoke when prompted by law enforcement. The Defendant was subsequently removed from the vehicle due to him attempting to place the vehicle in drive, furtive hand movements into the floorboard area of the vehicle and also due to the strong odor of Marijuana coming from the interior of the vehicle.

During a subsequent narcotics investigation and probable cause search of the vehicle, the following was discovered:

-Approximately nine-hundred and sixty-five (965) grams of suspected Methamphetamine. The substance was tested and yielded a presumptive positive result for the presence of Methamphetamine

-Approximately two-hundred and four (204) grams of suspected Heroin. The substance was tested and yielded a presumptive positive result for the presence of Heroin.

-Approximately one-hundred and sixty-seven (167) grams of suspected Fentanyl. This substance was field tested and yielded a presumptive positive result for the presence of Fentanyl. This substance showed evidence of attempted pill manufacturing due to being pressed into loosely shaped squares.

-Approximately five-hundred and three (503) grams of a liquid mixture Oxycodone/Promethazine. This substance was field tested and yielded a presumptive positive result for the presence of Oxycodone.

-Approximately thirteen (13) grams of suspected Marijuana. This substance was field tested and yielded a presumptive positive result for the presence of Marijuana/THC.

- -Two (2) digital scales with suspected Methamphetamine and Heroin/Fentanyl residue.
- One (1) suspected hand operated pill press with suspected Fentanyl residue inside.
- -One (1) torn corner of a grocery bag with suspected Heroin residue inside.

The Defendant refused to speak with law enforcement on scene upon being read Miranda warning from a prepared text. During the entire interaction with the Defendant, the Defendant refused to provide any information that would result in his identification. The Defendant only stated upon initial contact his name is "Steven". The Defendant was eventually identified by investigative techniques utilized by Deputy Lincoln.

Based on the above, your Affiant has probable cause to believe the Defendant, Stephen Scott WILSON, violated Florida State Statutes 893.135.1C4A: Trafficking in Fentanyl; 893.135.1F1: Trafficking in Methamphetamine; 893.135.1C3D: Trafficking in Oxycodone; 893.13.6B Possession of Marijuana (Less than 20 grams); 893.147: Possession of Drug Paraphernalia; and 843.02 Resist/Obstruct Officer without Violence.

This incident occurred in Okaloosa County, Florida.
