[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On August 8, 2019, the Honorable Judge Grinsted read and signed search warrant for the residence at 113 Kiwi Place Fort Walton Beach, FL 32548 Okaloosa County.

On August 16, 2019 at approximately 0600 hours law enforcement officers executed the lawfully obtained search warrant at 113 Kiwi Place Fort Walton Beach, FL 32548 Okaloosa County.

During the course of executing the search warrant the DEFENDANT Aleshia Yvonne Stewart was located inside a bedroom of the aforementioned address. According to the DEFENDANT she is a resident of 113 Kiwi Place. A search of the residence revealed items related to the investigation, to include, but not limited to a scale located on the dining room table. The scale white powder residue that field tested positive for the presence of cocaine. The scale was in plain view on the table and it was located within the common areas used by the DEFENDANT.

The scale had what appeared to be cocaine residue on which field tested positive for the presence of cocaine. With the aforementioned information the DEFENDANT is in violation of the following F.S.S. 893.147(1) Possession of Drug Paraphernalia. This offense occurred in Fort Walton Beach, Florida where your Affiant is a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On August 8, 2019, the Honorable Judge Grinsted read and signed two search warrants for the residence and vehicles at 113 Kiwi Place Fort Walton Beach, FL 32548 Okaloosa County. One search warrant was for the actual residence and the second search warrant was for a 1999 Chevrolet Tahoe on the property.

On August 16, 2019 at approximately 0600 hours, law enforcement officers executed both search warrant(s) at 113 Kiwi Place Fort Walton Beach, FL 32548.

The DEFENDANT Tyrecious Tyrone Robbins was located in the back bedroom of the home. According to the DEFENDANT he is a resident of 113 Kiwi Place.

Officers searched the residence and recovered a scale in plain view on the dining room table. The scale had a white power substance on it that field tested positive for cocaine. The table (and scale) were in commons areas of the home. Officers also searched the Defendant's person which revealed items to include, but not limited to: a key to the aforementioned 1999 Chevrolet Tahoe parked outside.

On this date, officers executed the second search warrant on the 1999 Chevrolet Tahoe parked on the curtilage of the premises. Prior to the search, officers noted the vehicle was locked. The search revealed more than 28 grams of a liquid substance that field tested positive for the presence of codeine, 1.6 pounds of marijuana, and five loaded firearms, located in the vehicle.

A review of Robbins criminal history revealed that he was convicted of a felony crime on June 18, 1998, regarding drug violations in Okaloosa County, Florida.

This offense occurred in Fort Walton Beach, Florida where your Affiant is a sworn law enforcement officer.

With the aforementioned information the DEFENDANT is in violation of the following F.S.S. 893.147(1) Possession of Drug Paraphernalia
793.23 (1a) Possession of a firearm by a convicted felon; 893.13 (1a2) Marijuana distribution; 893.135 (1c1) Trafficking of controlled substance
