[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On August 14, 2019, the juvenile defendant, Keyvon Dawson, committed the criminal offense of False Report Concerning the Planting of Explosives or The Use of a Firearm in a Violent Manner.

On the above mentioned date the juvenile victim, [REDACTED] observed the defendant in possession of e-cigarettes while in class at Niceville High School. The defendant confronted the victim in a classroom and in the hallway outside the classroom where he pushed the victim against the wall and threatened to beat him up. The defendant confronted the victim again in the classroom and told him that he was going to bring a gun and shoot him with his Glock. The victim disclosed past history he has had with the defendant and feels that the defendant is capable of carrying out the threat and is in extreme fear for his safety.

An interview was conducted with a juvenile witness, [REDACTED] who was in the classroom at the time of the incident. During the interview, the witness stated that he heard the defendant tell the victim that he would bring a gun and shoot him with his Glock. He also added that he heard the defendant tell the victim that he would find him off campus
