On August 25, 2019, at approximately 1:44 a.m., the Defendant, Vincente Paulos Garcia, was found to have burglarized a house and resisted arrest without violence.

On the above date, the Defendant, broke a glass bedroom window to the residence of Sibert Avenue. The residents/victims were awaken to the noise of the broken window and confronted the Defendant as he had made entry and was standing in a bedroom of the home. The Defendant was tangled in the drapes and the window frame was wrapped around the Defendants waist. The victim confronted the Defendant and escorted him to the backvard, out of the house. The Defendant identified himself as, "Vinnie Garcia" before he had departed the residence.

The Defendant was observed leaving the vicinity of the residence upon law enforcement arrival, and matched the description provided by the victims. Law enforcement made contact with the Defendant approximately fifty yards from the house at the corner of Sibert Avenue and Pine Street, where the Defendant was walking away from the scene at a fast pace. Law enforcement gave verbal commands for the Defendant to stop and drop to his knees. The Defendant failed to comply with a lawful command and turned away as if about to walk away. The Defendant was tazed as a result of his refusal to obey commands.

A show up was conducted and the victim was able to positively identify the Defendant as the individual who burglarized their house.

Post Miranda, the Defendant failed to answer any questions pertaining to this case, stating he did not break into any house. The broken window was valued at approximately \$500.00. The Defendant also had minor lacerations to his hands and feet from the window glass.

Based on the above facts, I have reason to and do believe, the Defendant, Vincente Paulos Garcia, did violate Florida State Statute F.S.S. 810.02 (3) Burglar to an occupied residence, and F.S.S. 843.02 Resisting w/o Violence. This incident occurred in Okaloosa County Florida, where I am a sworn Law Enforcement Officer.
