During contact with the Defendant, he made a spontaneous utterance to Deputy J. Burnham stating, "I broke the mother fucking windows. Take me to jail. I did it because Donald Trump owes me one trillion dollars and these vehicles belong to the Mafia." The Defendant was subsequently detained and read his Miranda rights. The Defendant continued to provide statements of breaking vehicle windows in the parking lot with rocks.

The Victim reported his Nissan Versa bearing Alabama registration had a rear driver side window on the vehicle damaged. Rocks were located inside and around the vehicle which matched the Defendant's admission as the item used to cause the damage. The victim estimated the total damage at approximately \$1,000.
