[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

I have reason to believe and do believe the defendant, Justin James Wilson, did commit the offense of Criminal Mischief, to wit;

On September 9, 2019 deputies responded to the Holiday Inn Resort at 1299 Miracle Strip Pkwy, Fort Walton Beach, Florida in reference to a disturbance. Upon arrival of the responding unit, Deputy J. Burnham, the Defendant was identified by a Witness who is an employee of the business. The Defendant was located in front of the business on a bench, passed out. The Witness stated she was notified by a guest of the Defendant damaging vehicle windows in the parking lot with an item that appeared to be his belt buckle.

During contact with the Defendant, he made a spontaneous utterance to Deputy J. Burnham stating, "I broke the mother fucking windows. Take me to jail. I did it because Donald Trump owes me one trillion dollars and these vehicles belong to the Mafia." The Defendant was subsequently detained and read his Miranda rights. The Defendant continued to provide statements of breaking vehicle windows in the parking lot with rocks.

The Victim reported his Nissan Versa bearing Alabama registration [REDACTED] had a rear driver side window on the vehicle damaged. Rocks were located inside and around the vehicle which matched the Defendant's admission as the item used to cause the damage. The victim estimated the total damage at approximately \$1,000.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On September 9, 2019 deputies responded to 1299 Miracle Strip Pkwy, Fort Walton Beach, Florida in reference to a disturbance.

Upon arrival of the responding unit, Deputy J. Burnham, made contact with a Witness who is an employee of the business. The witness identified the Defendant, Justin James Wilson as a suspect in numerous criminal mischief's to vehicles through out the business parking lot. The Witness stated she was notified by a guest of the Defendant damaging vehicle windows in the parking lot with an item that appeared to be his belt buckle.

During contact with the Defendant, he made a spontaneous utterance to Deputy J. Burnham stating, "I broke the mother fucking windows. Take me to jail. I did it because Donald Trump owes me one trillion dollars and these vehicles belong to the Mafia." The Defendant was subsequently detained and read his Miranda rights. The Defendant continued to provide statements of breaking vehicle windows in the parking lot with rocks.

The Victim reported his Nissan Maxima bearing Tennessee registration [REDACTED] sustained a broken back window which he estimated at approximately \$1,000. Rocks were located in and around the vehicle which matched the Defendant's admission as the item used to cause the damage.
