[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Corporal Tyler Williamson, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since January 2014. Your Affiant is currently assigned to the OCSO Field Services Division as a Corporal. Your Affiant being duly sworn states as follows:

On 9/11/2019, at or about 2245 hours, your Affiant was conducting patrol operations at the West side of the Marler Bridge, on Highway 98 (Okaloosa Island), Okaloosa County, Florida. While doing so, your Affiant observed two vehicle traveling at a high rate of speed, East on Highway 98, approaching his location. The two appeared to be in a speed competition and their speeds were determined to be 111 MPH in a 55 MPH zone, based on the reading from your Affiant's certified radar.

As the vehicles, identified as a black BMW sedan, bearing VIN # [REDACTED] and a dark colored Chevrolet sedan, approached your Affiant the pair slowed their speed. Your Affiant then again clocked the black BMW at 88 MPH in a now 45 MPH zone. As the two vehicle passed your Affiant, he pulled behind the pair. The BMW then appeared to accelerate, and your Affiant activated his emergency lights and siren on his marked Okaloosa County Sheriff's Office patrol vehicle.

After your Affiant did this the BMW then drove between two cars, causing one of the vehicle to have to merge into the emergency lane to avoid being hit. The BMW continued East on highway 98 into the city of Destin, Florida. The vehicle continued to speed going speeds greater than 90 MPH in a 35 MPH zone, attempting to elude your Affiant. As the vehicle approached construction on Highway 98, Destin, the vehicle turned onto Benning Drive where it continued to flee to the

intersection of Beach and Mountain Drive. The vehicle then entered into a empty lot at the intersection where it briefly paused.

As your Affiant approached to overtake the driver and vehicle, the vehicle accelerated at a quick pace, drove through a grassy shoulder, over a fire hydrant, causing damage to the hydrant, and back onto Mountain Drive. At this point the vehicle traveled 100 yards before having to stop due to damage. the vehicle stopped in front of 623 Mountain Drive, Destin, Okaloosa County, Florida. The driver and sole occupant of the vehicle was removed and identified as Andrew Michael Garrett (DEFENDANT).

Upon contact with the DEFENDANT the strong odor of an alcoholic beverage could be detected coming from his person when he spoke, and his eyes were glassy and red.

A check of FCIC/NCIC of the DEFENDANT's Florida license revealed he had numerous suspensions to include being labeled a habitual traffic offender as of 09/04/2018.

Post-Miranda the DEFENDANT did not want to speak with your Affiant.

Based on the evidence your Affiant has probable cause to believe the DEFENDANT, Andrew Michael Garrett, did violate Florida State Statute 316.061 (Traffic Crash Hit and Run); Florida State Statute 316.191.2a (Racing on a Roadway); Florida State Statute 316.192.3a1 Reckless Driving With Property Damage); Florida State Statute 316.193.1 (DUI); Florida State Statute 316.1935.3a (Fleeing and Eluding Disregard For Property); Florida State Statute 322.34.5 (Driving While License Suspended Habitual Offender).
