[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 9/11/2019, the defendant, Joshua Wade Turner was brought into the booking facility. While attempting to conduct the booking process, Mr. Turner become hostile towards the deputies. When asked if he was going to let us complete the process, Mr. Turner stated "no". He got up from the bench, and started towards where my partner and I were standing at the counter. My partner grabbed Mr. Turner's arm to stop his actions in moving further forward. I then stepped in and assisted my partner by grabbing Mr. Turner's other arm. While we had a hold on Mr. Turner, he kept resisting and pulling away from us. We had to assist Mr. Turner down the hall to a holding cell. Once at the holding cell, Mr. Turner resisted against us when we tried to put him in the holding cell. While resisting against the deputies, Mr. Turner turned his head and spat in my direction hitting me in the left eye and on my left side of my face/head.

Based on the above information I reason to believe and do believe that Joshua Wade Turner did intentionally spit on me committing the offense of Battery on a Law Enforcement Officer violating F.S. 784.07-2b. This offense did occur in Okaloosa County where I am a full-time Law Enforcement Officer.

This incident was captured on my body worn camera along with D/S Charest's camera.

Case-Closed with an arrest.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Joshua Wade Turner did in fact commit violations of Florida Statute 312.212 (1)(a) and 901.36(1) on September 11, 2019, in Okaloosa County.

I came in contact with Turner who I believed to be Patrick Alan Pearson, which I believed to have an active warrant. I ordered Turner to stop and asked him his name. At this point Turner stated his name was "Jose". I then asked the male to provide identification. Turner then provided a Florida identification with the name Patrick Alan Pearson, [REDACTED] Turner was arrested and later transported to the Okaloosa County Jail where his true identity (Joshua Wade Turner) was learned.

Due to Turner possessing an unlawfully issued Florida Identification and providing a false name, I have probable cause to believe Turner committed a violation of Florida Statute 312.212 (1)(a), Unauthorized possession of, and other unlawful acts in relation to, driver license or identification card and 901.36(1) Prohibition against giving false name or false identification by person arrested or lawfully detained; penalties; court orders. He did commit these violations in Okaloosa County, Florida, where I am a sworn Law Enforcement Deputy.
