Due to Turner possessing an unlawfully issued Florida Identification and providing a false name, I have probable cause to believe Turner committed a violation of Florida Statute 312.212 (1)(a), Unauthorized possession of, and other unlawful acts in relation to, driver license or identification card and 901.36(1) Prohibition against giving false name or false identification by person arrested or lawfully detained; penalties; court orders. He did commit these violations in Okaloosa County, Florida, where I am a sworn Law Enforcement Deputy.
