[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On September 16, 2019, the Okaloosa County Sheriff's Office Narcotics Unit executed a search warrant at 4201 Indian Bayou Trail Unit 21207, Destin, Florida. This residence was previously identified as being utilized by Stephannie MANEW to store, package, and distribute narcotics, to include heroin and methamphetamine.

During execution, no person was located inside. During a search of the residence, a grocery bag was located on the nightstand in the master bedroom. Inside this grocery bag, was two gallon sized Ziploc bags containing suspected methamphetamine and one gallon size plastic bag containing suspected heroin.

The suspected methamphetamine weighed approximately 2,000 grams, and the heroin weighed approximately eighty seven (87) grams. Both produced positive field tests for their respective substances.

Items, such as packaging materials and digital scales, were also located throughout the residence.

While a search of the residence was being conducted, and after the narcotics were discovered, MACNEW was observed arriving in the parking garage. Surveillance units detained MACNEW pursuant to the aforementioned narcotics violation. MACNEW elected not to answer any questions.

Also located within the residence, was documents, to include a lease agreement, with MACNEW's name. A receipt for Hobby Lobby in Destin was also located on the dining room table, for a transaction which occurred on September 13, 2019. Contact was made with management at Hobby Lobby, and video surveillance was obtained. MACNEW was positively identified as the person who conducted the transaction.

My investigation, which is based on statements from the suspect, witnesses, law enforcement observations, and collection of physical evidence, revealed that StephannieNicole MACNEW did violate Florida State Statue 893.135(1f1)- Trafficking in over 2,000 grams of methamphetamine, and Florida State Statue 893.135 (1c1)- Trafficking in Heroin. This incident occurred in Okaloosa County, Florida.
