[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On September 19, 2019, the juvenile defendant, Ronald Willingham, committed the criminal offense of False Report Concerning the Planting of Explosives or The Use of a Firearm in a Violent Manner.

On the above mentioned date the juvenile victim was in a verbal argument with the defendant while at school. The argument transpired after the defendant and other juveniles went to the victim's residence on 09/18/2019 trying to find him and beat him up. During this time, the defendant and other individuals found that the victim was not home, so began to throw things on his roof and around his yard.

Today, the victim confronted the defendant while at school and as he walked away, the defendant yelled, "I am going to shoot you." This was heard by several witnesses.

During a post Miranda interview, the defendant admitted to telling the victim that he was going to shoot him as he walked away from the verbal confrontation, and where multiple students could hear him.

Interviews were conducted with two juvenile witnesses who stated the victim and the defendant were arguing and they heard the defendant threaten to shoot the victim. The witnesses completed sworn written statements outlining what they witnessed.

The juvenile victims mother, Brandi Ryles-Waller, completed a Sworn Affidavit of Complaint.

This offense did occur in Okaloosa County Florida and is a direct violation of F.S.S. 790.163 False Report
