On 8/31/19, at approximately 1608 hours, the defendant Stephen Keith Cordova AKA "YG" violated F.S.S.

782.04 Attempted Homicide, F.S.S. 790.23 Possession of a Firearm by a Convicted Felon and F.S.S. 790.15(2) Discharging firearm from a vehicle within 1000 feet of a person by driving by the residence known as 28 Miller Street, Fort Walton Beach, Florida and discharging multiple rounds of a 9mm handgun towards the house striking victim Donald "DJ" Thomas Clay, Jr. in the upper thigh of his leg causing arterial damage requiring lifesaving surgery.

The victim Clay, in a sworn written Affidavit of Complaint, stated he was at 28 Miller Street on the afternoon of 8/31/19 attending his 7 year old daughter's birthday party. He described looking for something in his car which was parked in the front yard. Clay stated he was walking towards the back yard via the carport when "shots went off" and he was "shot in the upper left leg." He described continuing to the backyard and collapsing in the doorway of the kitchen entrance at the back of the house.

This incident was witnessed by four people who stated the following:

[REDACTED] was attending the birthday at 28 Miller Street and stated he was shooting basketball in front of this house when he saw a black, 2-door older model sports car with a spoiler stopped in the roadway in front of 25 Miller Street. [REDACTED] described two males with "dreads" inside the car talking with the resident of 25 Miller Street who was standing next to the car. [REDACTED] said he returned to the party in the back yard and immediately heard the gunshots and saw "DJ" run into the backyard bleeding.

[REDACTED] was sitting in the passenger seat of a friend's car parked in her front yard, talking with the victim, when she thought she heard fireworks. [REDACTED] then observed a black 2-door "sports like" car firing shots out of the passenger side. She ran after the car and observed the car had "messed up window tint" and a spoiler on the back. The car left at a high rate of speed. [REDACTED] ran into her house and discovered the victim with a gunshot wound.

[REDACTED] was attending the party and was in her car with [REDACTED] when the gunfire occurred. She saw a black 2-door car speeding away. [REDACTED] jump out of her car and run down the road. She ran into the home, grabbed her daughter and other kids then left the scene in her car.

[REDACTED] stated she was standing out front when a black, 2 door small car with a "fin" on the back slowed down then started shooting out of the passenger side towards 28 Miller Street. She heard 8-10 shots and the suspect car took off towards South Street.

The suspect vehicle was captured on video via a neighbor's security camera approaching the crime scene at approximately 4:08 pm heading north on Miller Street. The same vehicle is then seen traveling south on Miller Street, away from 28 Miller Street at approximately 4:09 pm. This vehicle was later identified as a 2010 Black Nissan Altima two

During the course of this investigation, other sources wishing to remain anonymous, have made contact with several different OCSO investigators providing information that "YG" was the shooter

information specifically identifying the defendant as the passenger

On 9/1/19 at approximately 0530 hours, the suspect vehicle was located parked in the driveway of 30 2nd Street, Shalimar, Florida. The defendant [REDACTED] walked out of this same residence, in the presence of law enforcement, and were escorted to the OCSO Headquarters building for an interview. The defendant [REDACTED] were present together when advised about this investigation.

I attempted to advise the defendant of his rights, pursuant Miranda, however the defendant interrupted and said he did not want to talk to me, he wanted an Attorney.

On 9/3/19, a search warrant was completed and signed by the Honorable Judge Angela Mason. The search warrant was executed on the black 2010 Nissan Altima. The following evidence was collected from the car:

Documentation bearing the name of [redacted] was observed within the car. Suspected marijuana, drug paraphernalia and two Glock magazines one of which contained two rounds of Luger FC 9mm hollow point ammunition. It should be noted, two (2) Luger 9mm shell casings were recovered from the crime scene.

A 9mm hollow point projectile was recovered from Kanise Brown's vehicle, which was parked in the front yard of 28 Miller Street when this incident occurred.

A field Gun Shot Residue (GSR) test was conducted on the right front interior door panel (near window) which resulted in a presumptive positive result for the presence of GSR.

A Criminal History Inquiry was conducted on the defendant which revealed that the defendant was convicted of violating F.S.S. 316.1935(3) Fleeing and Eluding at High Speed, which is a 2nd Degree felony.

Based on the above facts I have reason to believe and do believe the defendant, STEPHEN KEITH CORDOVA, violated F.S.S. 782.04 Attempted Homicide, F.S.S. 790.23 Possession of a Firearm by a Convicted Felon and F.S.S. 790.15(2) Discharging firearm from a vehicle within 1000 feet of a person. These violations occurred in Okaloosa County, FL where I am a sworn law enforcement officer.
