[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 10/16/19, I responded to a call for service regarding a 911 hang-up call at 536 Andros Road in Holt.

When I turned on to Andros from Log Lake, I observed the Defendant (Nemiah Barnett) walking down the middle of the road. Through previous contact, I knew that 536 Andros was the residence of the Defendant. The Defendant had a bag with a white substance in his right hand. The Defendant then concealed his hands in front of him, after seeing my patrol car. The Defendant then began walking at a faster rate and crossed the public road at an angle other than ninety degrees.

After verbally confronting him, the Defendant turned abruptly and threw the bag over his shoulder. He was then instructed to get on the ground to which he complied. The Defendant was found with an additional plastic bag of methamphetamine on him, along with a large amount of cash and two cell phones. The discarded bag was collected was found to contain methamphetamine. Inside that bag was an additional small bag containing additional methamphetamine.

The large bag was tested by Deputy Dowdy and tested positive for methamphetamine. The large bag weighed approximately 28 grams.
