[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 10/7/2019, I arrested James Francies Jenkins Jr in Okaloosa County, Florida, for an active arrestwarrant. Jenkins had a warrant for Sell Opium with 1000 ft of a School and Use 2 way Communication Device to Facilitate a Felony, Court Case # 19-3338. Once placed into handcuffs, Jenkins complained of chest pains and was transported to North Okaloosa Medical Center, located at 151 E. Redstone Ave, Crestview, FL, for treatment.

Jenkins handcuffs had to be removed for medical treatment. Jenkins was treated and waiting for release paperwork, when he went to use the bathroom adjoining his room. Jenkins exited the bathroom through a different door and began walking down the hall wearing blue scrubs and a stethoscope, disguised as a doctor. I recognized Jenkins attempting to walk away even though he had changed clothes. I yelled for him and he ignored me. I approached him and told him to stop at which time he began to run. Jenkins ran through the triage door and towards the exit. I chased Jenkins and he ignored commands to stop. I caught up to Jenkins as he was trying to exit the Emergency Room doors which lead to the parking lot. I grabbed Jenkins and pulled him to the ground, where he was secured in handcuffs.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

During the month of August 2018, Investigator Richards began receiving information about JAMES FRANCIS JENKINS selling prescription pills, specifically Dilaudid (Hydromorphone). This information came after JENKINS was arrested following a state-wide investigation for the same offense.

During the month March 2019, Investigator Richards [REDACTED] to conduct a controlled purchase of Hydromorphone pills from JENKINS.

[REDACTED] made contact with JENKINS via a law enforcement controlled electronic communication and requested to purchase a specific quantity of Hydromorphone 8mg pills. JENKINS instructed [REDACTED] via two-way communication device, to meet him at a specific location in Crestview, Florida to conduct the transaction.

Prior to any controlled purchase taking place, the [REDACTED] was searched with no illegal findings. Under the surveillance of law enforcement, [REDACTED] traveled to the meet location and made contact with JENKINS, as agreed. The

provided JENKINS with recorded police drug buy money in exchange for the predetermined quantity of Hydromorphone 8mg pills. Law enforcement visually identified JENKINS during the operation as the suspect who sold the narcotics. Surveillance was maintained on [redacted] made provided law enforcement, with the purchased pills. [redacted] was again searched with no illegal findings.

The purchased pills were identified by their markings, via drugs.com, and were confirmed to be Hydromorphone Hydrochloride 8mg. It should be noted that the location, set by JENKINS, is within 1000 feet of Davidson Middle School and Crosspoint United Methodist Church.

Based on the aforementioned facts and investigation, Investigator Richards has probable cause to believe JAMES FRANCIES JENKINS violated FSS 893.13.1c1 Sell Opium or Derivative, Schedule II, within 1000 Feet of a School/Place of Worship and FSS 934.215 Use of a Two-Way Communication Device to Facilitate a Felony. These offenses occurred in Okaloosa County, where I am a sworn law enforcement officer.
