[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Deputy Sheriff Anthony Gonzales, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since March 2018. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant being duly sworn states as follows:

On October 12, 2019, your Affiant conducted a traffic stop of a silver Honda bearing Florida registration II05XP for violating Florida State Statute: 316.183 (unlawful speed). Your Affiant visually estimated the Honda speed to be 40 MPH in a posted 20 MPH zone. Your Affiant utilized his certified calibrated agency issued Python radar which clocked the Honda at 38 MPH in a posted 20 MPH zone. The traffic stop was conducted near Clifford Street and Green Street within Fort Walton Beach.

Your Affiant made contact with the driver, ██████████ (Victim #1)(DOB: ██████████ 2005) who advised she was only fourteen (14) and did not possess a driver's license or identification card. Victim #1 advised she was given permission from ██████████, Aralia MARTINEZ-ZAMORA (Defendant) to operate the Honda. Victim #1 advised she departed her residence at ██████████ Fort Walton Beach, to wash laundry at 24 Hr Coin Laundry located at 611 James Lee Road, Fort Walton Beach. Victim #1 advised she then traveled to Chic-fi-la located at 743 Beal Parkway, Fort

Walton Beach, to get food while waiting for the laundry to finish.

two (2) children, (Victim #2)(DOB: -2008) and (Victim #3)(DOB: -2010) were also within the Honda with Victim #1.

Victim #1 advised she traveled on Green Acres Road, Beal Parkway, Racetrack Road, James Lee Road, Mayflower Avenue, and Clifford Street on the way to the laundry mat. Your Affiant conducted the traffic stop at 1409 hours when their was heavily traffic flow on all the aforementioned roadways.

Your Affiant contacted the Defendant via telephone who arrived on scene a short while later. Post Miranda Warning the Defendant advised the following:

The Defendant advised she gave Victim #1 permission to operate the Honda without proper supervision or a driver's license. The Defendant advised she departed the residence prior to Victim #1 leaving and did not know Victim #2 or Victim #3 went to the store with her. The Defendant advised she had a friend at the residence but did not delegate supervision of the children.

The Defendant has also never been issued a driver's license in any state to receive proper training on how to operate a motor vehicle.

Based on the above, your Affiant has probable cause to believe the Defendant violated Florida State Statute 322.35: Permit unlicensed minor to operate a motor vehicle and 827.03.2d(3x): Child neglect without great bodily harm.
