[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On October 30, 2019, I investigated a burglary which occurred at the BP gas station, located at 1247 N Eglin Pkwy, Shalimar, FL. Deputies arrived on scene and observed the front door glass shattered, and a brick and a 4 x 4 piece of lumber laying on the ground near the door.

During a canvass search of the area, I located a white male walking west on 8th Ave, which is located two streets over from the aforementioned business. The male subject identified as, Michael Tabor. Tabor was also openly carrying a 15 pack of Natural Ice beer which was still cold and covered in condensation.

During a post Miranda interview, the defendant agreed to speak with me and consented to a search of his person. A noticeable bulge was observed in the defendants right sock near his ankle. A total of four packs of 305's in their original packaging were located inside the defendants sock along with one freshly opened pack which located inside the defendant's shirt pocket. I located an additional two packs of Native brand cigarettes in the defendants back right pants pocket. All of these items were later confirmed as being stolen from the business by the store manager, Anita Brown.

During a non-custodial interview with the defendant, he admitted to breaking into the business to steal the beer and cigarettes. The defendant stated he waited on the property for the clerk to leave and then broke the window to gain entry. He confirmed that he used the brick to break the store window. Tabor stated that he acted alone during said burglary.

Per the sworn written affidavit of complaint, the total estimated damage to the front door is \$500.00 and the estimated amount of the stolen merchandise is \$32.89.

Video surveillance footage from the store revealed the defendant breaking the front window and entering the store where he retrieved the previously mentioned items. Store manager Anita recognized the defendant as a regular customer who frequents the store with his mother. When she reviewed the store video she, immediately stated, "that's Michael".

Based on this information, the defendant, Michael Tabor, committed the offense of burglary of an unoccupied structure F.S.S. 810.02.4a, criminal mischief F.S.S. 806.13.1b2, and petit theft, F.S.S. 812.014.2e.
