[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On November 7, 2019, a search warrant was signed for 121 2nd Street Niceville, Florida 32578 for the investigation for violations of Florida State Statute 827.071(5) Possession of Child Pornography.

On November 7, 2019, the search warrant was executed at the above stated residence. During the search warrant a PNY 16 GB black slide port rectangle in shape thumb drive / flash drive was found in Tyler Cleere's room. During a Forensic review of the thumb drive / flash drive a minimum of 30 images and videos of child pornography were discovered on the thumb drive / flash drive.

During a post Miranda Interview Tyler Cleere admitted that the room the thumb drive / flash drive was discovered was his room and that all the items in the room were his. Cleere also admitted the PNY 16 GB black slide port rectangle in shape thumb drive / flash drive was his as well. Cleere stated he knew what was on the thumb drive as well.
