[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On November 1, 2019 I responded to North Okaloosa Medical Center in reference to a stabbing. Upon arrival, the victim Aubrey Brooks stated per sworn verbal statement, he went to 3921 Chambray Road to pick up his friend Matthew Watkins. He advised the DEFENDANT Billy Jack KEENE opened the door of Watkins home and began a verbal altercation with him. As he turned to walk away from the DEFENDANT the DEFENDANT grabbed him from behind and stabbed him in the back with a knife. Brooks clothing displayed evidence of a puncture along with blood in the area of the wound.

Witness Vanessa Tejo stated per sworn statement that as she was waiting for Brooks and her friend Matthew Watkins to come to the car, she saw KEENE chasing Brooks into the woods. Tejo said KEENE told her that he would continue to attack Brooks until Brooks got the hint. Tejo picked up Brooks up the road and drove him to the hospital.

I then went to 3921 Chambrey Road to locate KEENE and Watkins. Upon arrival commands were given to all parties within the residence to come out. Eventually Watkins came out and stated that KEENE was no longer in the residence and he did not know where KEENE went. Watkins was not helpful and stated that the only thing he knew was, KEENE ran out of the residence after someone. While at Watkins' residence, a set of keys and a folding knife was on the concrete slab where the altercation between KEENE and Brooks occurred. KEENE was not located and was seen on neighbor's security camera shortly after the altercation, sitting on the neighbors porch wrapped in a blanket. KEENE departed after a short period of time.

Based on the sworn statement of the victim, Aubrey Brooks, along with the statements of the witnesses, Tejo and Watkins, coupled with the injury and physical evidence I have reason to believe and do believe that the defendant Billy Jack KEENE did violate F.S.S. 784.045.1a2 Aggravated Battery with a deadly weapon; when he intentionally used a
