[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On December 9, 2019, the DEFENDANT, Stephanie Rose BERG, did commit the following offense in violation of Florida State Statute 827.03(2)(d); Neglect child without great bodily harm. Facts to support probable cause are as follows:

At approximately 2101 hours, I conducted a traffic stop on a red Mazda sedan bearing Florida vehicle registration [REDACTED] for no headlights on during night time hours. This offense is in direct violation of Florida State Statute 316.217 and occurred on Denton Boulevard at Pryor Middle School. During the roadside investigation, the DEFENDANT was placed under the arrest for the suspicion of driving under the influence. The DEFENDANT had [REDACTED] two children within the vehicle who were approximately 6 months old and 3 years old. The DEFENDANT admitted that she consumed alcohol and should not be operating a motor vehicle.

This offense did occur within Okaloosa County, Florida, where I am a sworn law enforcement officer.
