[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

From October 2017 through August 21, 2019 the Defendant Stephanie Sanchez Starks (DOB 01/03/87, aged 30-32) violated FS 794.05 Unlawful Sexual Activity with Certain Minors against the Victim SAC (12/22/2000, aged 16-18).

The Victim stated in sworn written and verbal statements that in October 2017, when he was 15 years of age and while at the Defendant's home for the purpose of babysitting her children, the Defendant grabbed him forcefully by his shirt, kissed him in a sexual manner on his mouth, then initiated sexual intercourse with him in the bedroom of her residence. The Victim stated this was his first ever sexual encounter. The Victim described having then engaged in sexual intercourse and oral sex with the Defendant at her residence, at his parents residence, in her vehicle and at a local park numerous times between October 2017 - August 21, 2019. Per the Victim, he and the Defendant were "in love" and "planning to move away together to live as a family" with the Defendant's children after she divorced her husband. Per the Victim, the relationship ended on 8/25/19 when he voluntarily shared the details of his relationship with the Defendant's husband, Justin Stark in the presence of his parents and a mutual friend, [REDACTED]

In sworn verbal and written statements, the Victim's mother, [REDACTED] stated that on 8/21/19 her son told her had been involved in a sexual and romantic relationship with the Defendant since he was 16 years old commencing when the Defendant's husband deployed to North Carolina.

In sworn verbal and written statements, Justin Starks stated on 8/21/19 he learned his wife, the Defendant, had been seen kissing the Victim in a sexual manner while at a local bar. Justin Starks stated he asked the Defendant about this and she said it was "just drunk kissing." Justin Starks stated on 8/25/19 he was told by the Victim that he and the Defendant had been romantically and sexually involved since September of 2017 and that they "had sex three weeks ago." Justin Starks stated on 8/25/19 he confronted the Defendant about her relationship with the Victim. The Defendant admitted to the relationship stating it was two weeks ago not one since she "had fucked" the Victim. The Defendant stated

to Justin Starks that her relationship with the Victim started when he was 17 not 16. These statements made by the Defendant were done so in the presence of [REDACTED] Per Justin Starks, later in the day on 8/25/19, the Defendant stated to him that her relationship with the Victim was her "fantasy life."

In sworn verbal and written statements, [REDACTED] corroborated that on 8/25/19 the Defendant stated to Justin Starks that she had "fucked" the Victim and described being in a sexual relationship with the Victim since he was 17 years old.

In sworn verbal and written statements, [REDACTED] stated she confronted the Defendant on several occasions about the inappropriate closeness of her relationship with the Victim, to include having the Victim stay the night at her residence while the Defendant's husband was deployed.

In sworn verbal and written statements, [REDACTED] stated on 8/15/19 he observed and photographed the Defendant kissing the Victim in sexual manner while they were parked behind the garage at WalMart in Fort Walton Beach, FL.

The Defendant's legal counsel contacted me on 08/16/19 to advise me the Defendant would not be made available to law enforcement for an interview regarding this case.

Based on the facts as presented above I have reason to believe and do believe that the Defendant did in fact violate Florida Statute 794.05 Unlawful Sexual Activity with Certain Minors. This offense occurred in Okaloosa County where I am a sworn law enforcement officer.
