[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On December 16, 2019, at approximately 1517 hours, ID/S Biernacki #390/1753, was dispatched to a Stolen Vehicle that had just occurred at the Santa Rosa Mall which is located at 300 Mary Esther Boulevard, Mary Esther, FL. Dispatch advised a black Hyundai Sonata had been stolen from the parking lot, outside JC Penney's Department Store within the last ten minutes. The owner of the vehicle was still on scene and provided a Sworn Affidavit of Complaint in regards to this case to D/S L. Stevenson.

While en-route to the call I observed a black Hyundai Sonata bearing Florida tag# [REDACTED] on Beal Parkway traveling northbound in the inside lane. I overtook the vehicle and confirmed it was the stolen vehicle as it turned left onto Beal Extension towards Union Street. I activated my emergency lights and sirens in an attempt to conduct a traffic stop.

The vehicle began to flee down numerous side streets before striking a vehicle as it turned west onto Green Acres Road from Beverly Street. I continued pursuing the vehicle until the pursuit ended in the rear yard of 706 Scott Street after it had crashed through two fences while driving in reverse.

The Defendant, later identified as Lewis Hudson by his Florida Driver's License, then exited his vehicle and fled on foot over a privacy fence. Once over the fence the Defendant began to comply with verbal commands. Prior to securing him in handcuffs he stated he was armed with a handgun.

After securing the Defendant in handcuffs the following items were removed from his person; Franklin batting gloves, black latex gloves, a car lock picking kit, a Springfield XD-40 Sub Compact Pistol (concealed in his waistband) with two magazines and ammunition, a clear container with suspected methamphetamine residue. A glass smoking device was later found in the vehicle with suspected methamphetamine residue. All items were seized as evidence.

As a result of the investigation the Defendant was arrested and charged with Grand Theft of a Motor Vehicle in violation of Florida State Statute 812.014.2c6, Fleeing and Eluding with lights and Sirens Active in violation of Florida State Statute 316.1935.2, Driving with a knowingly suspended license confirmed by the defendant for failure to turn in his tag and also confirmed suspended on 10/31/19 by FCIC/NCIC in violation of Florida State Statute 322.34.10b1, Leaving the
