[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 12/02/19, while conducting patrol operations in Destin, FL, I entered the Circle K gas station located at 701 Harbor Blvd., Destin, FL 32541. Inside the store, I observed the defendant, Holden Danjean, at the counter writing something on a piece of paper to the store clerk [REDACTED]. A few moments later while outside, I observed Holden exit the store and leave the parking lot. I approached [REDACTED] who said, "I think he just tried to rob me," and she showed me the handwritten note from Holden. I viewed the note which said, "all I need is the timer on safe," and, "you give false description."

Post Miranda, Holden said he was in the store and wrote the note to [REDACTED] in an attempt by them both to rob her boyfriend at another location.

[REDACTED] provided a sworn verbal and affidavit of complaint saying Holden came in and began writing the note. Once she read the note and saw he was talking about opening the safe she became fearful for her safety.

[REDACTED] never took her eyes off of me while I was in the store because she was worried. This was an obvious indicator of distress. She then observed Holden writing something else on the note, which was the false description statement. Holden later told her to throw the note away, then he left the store. [REDACTED] does not know Holden, does not

have a boyfriend, and did not talk to Holden about robbing a boyfriend. She also said the safe in the store is on a timer.

Based on the above information, I do believe the defendant Holden Danjean wrote the note asking about the timer on the safe in the store in an attempt get the money out of the safe and attempted to tell [redacted] to give a false description of himself to get away after the robbery. His actions placed [redacted] in fear for her safety. This is a violation of F.S.S. 812.13(2)(c)(3)(a) Robbery (Attempted). This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
