[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Deputy Sheriff Larry Carter II, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since July 2019. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant being duly sworn states as follows:

On 12/25/2019, Danielle HACKMEYER-COWART (Witness), Nathan HACKMEYER (Victim), and Laurie HACKMEYER (Victim) became involved in a verbal argument which turned into a physical altercation. This altercation took place at 128 7th Avenue, Shalimar, Okaloosa County, Florida.

On 12/25/2019, at 1720 hours, COWART returned to her address identified as 128 7th Avenue, Shalimar, Okaloosa County, Florida, to pick up some belongings after having an argument over the telephone with Jason GODWIN (Defendant). COWART along with Nathan HACKMEYER and Laurie HACKMEYER entered the bathroom located in the main bedroom. The Defendant observed Nathan HACKMEYER with a money jar in his hands and became instantly enraged. The Defendant then grabbed a small hatchet with a black handle and rushed towards the bathroom door.

Nathan HACKMEYER, for fear of his safety, secured the bathroom door with the assistance of Laurie HACKMEYER. The Defendant then began destroying the door with the hatchet and with his feet until the door was destroyed and made entry. The Defendant attempted to attack Nathan HACKMEYER with the hatchet. Nathan HACKMEYER, in fear for his safety, tried to restrain the Defendant.

The Defendant raised the hatchet in an attempt to swing it downwards. Laurie HACKMEYER grabbed the handle of the hatchet, injuring her right arm in the process. The Defendant then halted his attack and left the residence to dispose of the hatchet.

Your Affiant observed Laurie HACKMEYER who had minor injuries in the form of a small laceration and abrasion to her right arm.

The above was determined by interviews with the Defendant, Victims, and visual evidence.

Based on the above, your Affiant has probable cause to believe the Defendant, Jason GODWIN, did violate Florida State Statutes 784.021 1a Aggravated Assault with a Deadly Weapon and 784.05 2 Cupable Negligence.
