[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

The DEFENDANT, Joesph Thomas Matey knowingly or willfully violated FSS 827.03(2)(c)- Child Abuse by:

Committing intentional act(s) that could reasonably be expected to result in mental injury to the victim,

[REDACTED] 2002, during the year of 2017. The victim was under the age of 18.

The victim was removed from public school in 2017. The DEFENDANT told the victim he would enroll him into a different school and failed to do so. The victim had to care for [REDACTED] who required 24 hour care and

extensive duties and responsibilities, beyond the realm of a child. Because of this expectation, the victim was required to monitor [REDACTED] during these shifts which ranged from 5-14 hours. During this time, the victim was expected to sit next to [REDACTED] and remain awake and alert. The victim was also required to work alongside the DEFENDANT after "watch" usually getting approximately 5 hours of sleep a night.

Post Miranda, the DEFENDANT referred to this 24 hour care for [REDACTED] as "watch" and concurred these shifts would become substantially longer as the victim grew older. The DEFENDANT described the responsibilities as: monitoring medical equipment such as a ventilator, vital signs, feeding and caring for [REDACTED] every need. The DEFENDANT also admitted the victim must remain awake and in very close proximity to [REDACTED] the DEFENDANT stated the victim refused to enroll in school, despite his responsibility to ensure the victim was in compliance with schooling. The defendant stated the victim asked to work alongside the DEFENDANT. The defendant admitted he failed to follow through in enrolling the victim into a new school.

The victim completed a psychological evaluation performed by Dr. Julian Salinas, a licensed psychologist. Dr. Salinas reported the victim exhibits substantially lower performance in academics which are consistent with educational deprivation given his age, subject to exploitation by the DEFENDANT in both labor and in home expectation to care for his disabled mother for long periods of time. Dr. Salinas also provided positive findings for mental injury.

Based on the aforementioned facts I have probable cause to believe and do believe the DEFENDANT did willfully violate FSS 827.03(2)(c)- Child Abuse. This incident occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.
