[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Deputy Sheriff Chad Biernacki, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since November 2019. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant previously served as a Deputy Sheriff for 12 years with the Walton County Sheriff's Office. Your Affiant being duly sworn states as follows:

On January 15, 2020, at 0359 hours, your Affiant, attempted a traffic stop of a silver Honda Accord bearing Florida registration 55GPG at the intersection of Martin Luther King Boulevard and Freedom Way, Ft. Walton Beach, Okaloosa County, Florida for failing to obey at a traffic control device (Fog and Center Line), along with faulty equipment (brake lights stuck on) and the registered owner was showing to have a suspended Florida License.

Upon activation of your Affiant's vehicle emergency lights, on Martin Luther King Boulevard, the Defendant conducted a u-turn and headed south towards Lovejoy Road. Your Affiant activated his emergency siren and the Defendant accelerated heavily while fleeing south on Hill Street. The Defendant continued to flee through several stop signs and red lights as the pursuit continued onto Hollywood, Adam, Audrey, back to Hollywood, then Coral, Driftwood, Miracle Strip, Bryn Mar, Argyle, back to Bryn Mar, crossing Miracle Strip and ultimately ending on Islandview Drive where the vehicle struck a portable toilet as it came to a stop.

The Defendant exited the vehicle and fled on foot. Your Affiant gave chase and apprehended the Defendant after he fell while crossing over a three to four foot retention wall. While on the ground and prior to being placed in handcuffs the Defendant was seen discarding a glass pipe with cocaine residue (positive field test). Once secured the Defendant was identified as Larry HOSS Jr., by his Florida Identification Card.

Your Affiant conducted a records query and confirmed the Defendant had a suspended license with prior convictions on 11/01/2000, 03/07/2006, and 07/03/2007. The information was confirmed using NCIC/FCIC along with DAVID it was also confirmed by OCSO Dispatch.
