[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On January 7, 2019, the Okaloosa County Sheriff's Office Narcotics Unit, with assistance from the Fort Walton Beach Police Department, Drug Enforcement Administration, and Federal Probation and Parole, executed a narcotics search warrant at 893 Shalimar Court, Shalimar, Florida, which was identified as the residence of Rodney Jerome MCNABB (AKA Hervie TODD III).

A knock and announce was conducted on the front door. When the knock and announce started, an unknown person entered the master bathroom. This person was given numerous verbal commands to exit the bathroom.

Eventually MCNABB, along with his wife, and three juveniles exited the residence and were detained.

Just prior to searching the residence, MCNABB made spontaneous statements, stating all the "stuff" was his and to keep his family out of it.

During post Miranda statements, MCNABB stated there was 1.5 to 2 kilograms of cocaine inside the residence, along with approximately 20-25 ounces of heroin. Furthermore, MCNABB stated there was two firearms inside the residence. One was located inside the safe in the master bedroom, and the other was in the master bathroom in a drawer.

MCNABB stated the combination to the safe, was inside his wallet. Inside of MCNABB's wallet, was a business card, with directions on how to open the safe. Following these directions, the safe was opened.

Inside the safe was an AK-47. This rifle had a magazine containing 7.62 caliber rounds. Furthermore, inside the safe was kilogram of suspected cocaine, approximately 1022 grams of heroin, and 234 grams of unknown pills. The heroin was packaged into thirty-six (36) separate ounces, which is indicative of heroin distribution. Also inside the safe was \$108,520 in US Currency.

The bed in the master bedroom had drawers underneath them. On the side of the bed that was identified as belonging to MCNABB, approximately 996 grams of cocaine was located. This cocaine was packaged into thirty-five (35), one ounce bags of cocaine. One of these bags of cocaine was field tested, which produced a positive result for cocaine. Also, approximately 150 grams of heroin was located with this cocaine. This heroin was packaged into five (5) separate one ounce packages. Also, approximately seventy-nine (79) grams crack cocaine.

In the master bathroom, just like MCNABB stated, a Glock model 42 handgun located.

Throughout the master bedroom and master bathroom, approximately \$28,930 in US Currency was located.

According to a criminal history check, MCNABB has been convicted of seven (7) felonies in the State of Florida. Furthermore, MCNABB served 198 months in the Federal Bureau of Prisons for narcotic trafficking offenses and was released to Federal Supervision in October 2019.

My investigation, which is based on the statements of the suspect and witnesses, collection of physical evidence, research in law enforcement databases, and law enforcement observations, revealed that Rodney Jerome MCNABB (AKA: Hervie TODD III), did violate F.S.S. 893.135(1b1) - Trafficking in Cocaine over 2000 grams, F.S.S. 893.135(1c1) - Trafficking in Heroin over 1000 grams, F.S.S. 790.23(1a) - Possession of a Firearm by Convicted Felon (2 counts), F.S.S. 918.13 - Destruction of Evidence. These offenses occurred in Okaloosa County, Florida.
