[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

I have reason to believe and do believe the defendant, Kareem Rodolfo Mitry, did commit the offenses of Possession of a Firearm by a Convicted Felon, Possession of a Firearm while in Commission of a Felony, Trafficking in MDMA (more than 200 grams), and Possession of Marijuana with Intent to Distribute, to wit;

On January 9, 2020, using my tested and calibrated radar, I stopped a 2011 black Mercedes bearing FL tag 6758YK for speeding 53 MPH in the 35 MPH zone on U.S. Hwy. 98 near the intersection of Beach Drive in Destin, FL. The defendant was identified as the driver and sole occupant of the vehicle. The defendant was seen reaching under the drivers seat by Cpl. R. Shelly and the defendant was removed from the vehicle for officer safety. Through the open drivers door, while standing outside the vehicle, the handle of a handgun could be seen sticking out from under the drivers seat. Okaloosa County Sheriff's Office communications center advised the defendant was a convicted felon and I confirmed he was a convicted felon by checking his criminal history through NCIC/FCIC. The handgun was later discovered to be loaded with one in the chamber.

Canine Deputy A. Costantini walked his canine around the vehicle and he advised me his dog alerted to the odor of narcotics from the vehicle. During a search of the vehicle, there was approximately 270 grams of multicolored MDMA pills in a plastic grocery bag, within a green crown royal bag, laying on the drivers side floorboard. The MDMA pills tested presumptive positive for MDMA in a field test.

Behind the drivers seat, on the backseat, was a black backpack which had two sperate plastic bags containing suspected marijuana. Next to the backpack was another plastic grocery store bag with suspected marijuana. The substances tested presumptive positive for THC in a field test. The approximately weight of the three bags of suspected marijuana weighed approximately 795 grams. Per my training and experience this amount of marijuana is a distribution amount. The defendant had approximately \$7257 in cash in the vehicle, some of it being in what is commonly referred to as street folds.

Based on my investigation, I have reason to believe and do believe the defendant, Kareem Rodolfo Mitry, did commit the offenses of Possession of a Firearm by a Convicted Felon, F.S.S. 790.23(1)(a); Possession of a Firearm while in Commission of a Felony, F.S.S. 790.07(2); Trafficking in MDMA (more than 200 grams), F.S.S. 893.135(1)(k)(2)(b); and Possession of Marijuana with Intent to Distribute, F.S.S. 893.13(1)(a)(2). These offenses occurred in Okaloosa County, FL, where I am a sworn law enforcement officer.
