[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 1/30/20, between the hours of approximately 1720-1800, the Defendant, Amy D. Lavandier, (DOB 03/20/86) violated FS 827(3)(2)(a) against Victim [REDACTED] (11).

The Complainant is the Paramour of the Defendant and shares a residence with her. On 01/31/20 the Complainant contacted law enforcement to report the Defendant had been physically abusive to the Victim and the abuse was captured on video. The Complainant forwarded video footage from [REDACTED] "nanny cam" to law enforcement.

On 01/31/20 this video footage was viewed by Your Affiant. In the video footage, the Defendant is observed punching the Victim in the head no less than 15 times, kicking the Victim about her body no less than 10 times, striking her in the face with shoes no less than 9 times, shoving the victim 3 times, and punching the Victim in her head causing it to bounce off a baby gate and wall. Additionally, while committing these acts, the Defendant can be heard repeatedly screaming at the Victim "are you mother fucking stupid?" and "I hate you. I mother fucking hate you. Do you know that...how much I hate you?". Throughout the approximately twenty minutes of abuse, the Victim can be heard screaming and crying out in pain.

On 01/31/20, at approximately 1030 AM, your Affiant observed the Victim while she was being evaluated for injuries. Your Affiant observed multiple abrasions, bruises and contusions on the Victim's face, head, arms, back, buttocks, neck and legs. The Victim stated to the medical staff in Your Affiant's presence that she had been hit the previous night by the Defendant.

On 01/31/20, in a Post Miranda interview, the Defendant confirmed that she had acted towards the Victim in the manner described above. The Defendant further stated that she also repeatedly hit the Victim with a belt during this

same incident. Per the Defendant, she did not blackout or "snap", she was intentionally giving the Victim an "ass whooping" to get her to behave.

Based on the facts as presented above, your Affiant has reason to believe and does believe that on 01/0/20 the Defendant, Amy D. Lavandier, did, in fact, commit the offense of Aggravated Child Abuse in violation of FS 827(3)(2)(a). These offenses occurred in Okaloosa County where your Affiant is a sworn law enforcement officer.
