[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February 8, 2020 hrs, the victim, Kay Shipp reported the theft of several pieces of jewelry, to include a 3 strand gold bracelet valued at \$ 2000 US dollars. Also reported as stolen a diamond necklace with diamonds in an S shape design. Other pieces of jewelry are also missing.

Kay Shipp states that her son, Chase Shipp stays at her house and has access to her jewelry.

On 12/14/2019 Chase O'Neal Shipp did pawn two pieces of jewelry as documented with Leads on Line, ticket # 1368179073, (pawn). One piece was the S shaped diamond necklace, valued at \$ 1200 dollars and pawned for \$ 70 dollars. The second piece was a pair of gold flip flops which were pawned for \$ 30 dollars.

Kay Shipp did identify each of these pieces as her property.

On 2/9/2020, Chase O'Neal Shipp, did pawn a gold three strand bracelet valued at \$ 2000 dollars, per Leads on Line, ticket # [REDACTED] (pawn) for \$ 500 dollars.. Kay Shipp did identify this three strand bracelet as her property.

On 2/11/2020, approximately 2100 hrs. Chase Shipp was detained and at 2120 hrs, post Miranda Shipp stated that he did it for heroin, " all for heroin".

The two pawn transactions occurred at Cash America Pawn, 20 Eglin Parkway, Fort Walton Beach, Florida, within Okaloosa County, Florida.

Based on the affidavit of complaint from the victim, Kay Shipp and the pawn transactions identifying Chase O'Neal Shipp as presenting these items as his own, I have reason to believe and I do believe that Chase O'Neal Shipp has violated the following Florida State Statutes, 538.04.4b, knowingly gave false verification of ownership and received money from a secondhand dealer for goods sold, consigned, or traded.

This offense did occur in Okaloosa County, Florida where I am a certified Law Enforcement Officer.
