[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February 12, 2020 information was received from a Confidential Source about a male, identified as Donald Reco BUTLER, wishing to purchase 250 grams of cocaine. At the direction of Law Enforcement, the Confidential Source made contact with BUTLER, via telephone, and arranged the narcotics transaction. The Confidential Source agreed to provide 250 grams of cocaine in exchange for US Currency. BUTLER agreed on the price of the cocaine, and stated he would meet the Confidential Source for the purpose of purchasing cocaine. The meeting location was set within Fort Walton Beach, Florida.

On the same date, BUTLER traveled from Pensacola, Florida, to the meeting location, for the purpose of purchasing 250 grams of cocaine. BUTLER was provided a vehicle description in which the cocaine would be located, and was instructed to leave the US Currency. Approximately 250 grams of cocaine was placed in the vehicle and secured. Prior to BUTLER arriving, the vehicle was unlocked and kept under constant law enforcement surveillance. When BUTLER arrived, he was observed by surveillance units entering the vehicle containing the cocaine, and begin looking around. While BUTLER was inside the vehicle, law enforcement approached and took BUTLER into custody without incident.

Once BUTLER was detained, a black bag was located on the ground where BUTLER was initially contacted. Inside this bag was a large amount of US Currency, which matched the agreed upon purchase price for the cocaine.

During post Miranda interview, BUTLER admitted to traveling to Fort Walton Beach from Pensacola for the purpose of purchasing narcotics. BUTLER attempted to say he was purchasing a large amount of marijuana, which based on street prices, did not match the amount of US Currency BUTLER claimed to be paying.

My investigation, which is based on statement from suspects, witnesses, collection of physical evidence, and observations by law enforcement, revealed Donald Reco BUTLER, did violate F.S.S. 893.135 (1b1)- Trafficking in Cocaine over 200 grams and F.S.S. 924.215- Use of a two way communication device to facilitate a felony. These offenses did occur in Okaloosa County, Florida.
