[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 2/3/2020, at approximately 1910 hours, Shawn Chaplin (Defendant), violated F.S.S 843.02 Resisting Officer without Violence, F.S.S 784.07(2b) Battery on a Law Enforcement Officer (3 counts), F.S.S 784.02.1a Aggravated Assault with a Deadly Weapon, F.S.S 810.02(2b) Armed Burglary, F.S.S 812.13.2a Armed Robbery, and F.S.S 812.014(2c6) Grand Theft: Auto. This incident occurred at 117 W John Sims Pkwy, Niceville, Okaloosa County, Florida.

On the aforementioned date, Deputies arrived at the stated location in regards to an armed disturbance in which the Defendant was the suspect. Per Brendan Dologhty (victim), the Defendant stated "give me your fucking keys" and attempted to strike him with an unknown black object, later discovered to be a knife. The Defendant then ran to an unrelated nearby vehicle (2016 white Nissan Frontier bearing FL tag IMYH53) and gained access by an unlocked driver side door attempting to steal it.

The Defendant was then observed by Deputy Stinson entering the stated vehicle. The Defendant advised he had a gun, shut the driver door and barricaded himself inside, depriving Brian Feiste (victim 2) of his vehicle. Deputies observed a large knife in the hands of the Defendant.

The Defendant appeared upset and became verbally aggressive towards law enforcement. The Defendant refused multiple commands to show his hands, drop the knife, and exit the vehicle. Subsequently a K-9 was deployed and deputies placed the Defendant in custody.

As Deputy Hamilton was accompanying the Defendant in the ambulance, the Defendant intentionally spat on Deputy Hamilton's face. While at Twin Cities Hospital the Defendant was placed on to a hospital bed and spat on Deputy Hamilton's face again. A short time later as medical staff was assessing the Defendant's injuries, the Defendant kicked Deputy Hamilton on the left cheek.

While conducting the investigation the Defendant knew or should have known Deputies were law enforcement officers, as we were wearing our Okaloosa County Sheriff's Office patrol uniforms with our badges exposed.

The Defendant was transported to Okaloosa County Jail.

Based on the above facts, I believe the Defendant violated F.S.S 843.02 Resisting Officer without Violence, F.S.S 784.07(2b) Battery on a Law Enforcement Officer (3 counts), F.S.S 784.02.1a Aggravated Assault with a Deadly Weapon, F.S.S 810.02(2b) Armed Burglary, F.S.S 812.13.2a Armed Robbery, and F.S.S 812.014(2c6) Grand Theft: Auto. This incident occurred in Okaloosa County, where I am a sworn law enforcement officer.
