[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On January 31, 2020 the Defendant, Thomas Lee Findley, violated Florida State Statute 784.021.1b, Aggravated Assault with intent to commit a felony, To wit:

At approximately 1215 hours your defendant did point and fire one single round, from a hunting style rifle, at the victims, vehicle. The victim stated she attempted to pull in her driveway when she was stopped by the defendant who was standing in the driveway pointing the rifle at her. The victim stated she observed the defendant fire one round at her vehicle which she then fled the area. The victim stated the defendant and her have been in a married relationship for the past 20 years, living in the same house acting as a family. There was no indication the fired round struck the vehicle.

Contact with the defendant was attempted which he fled the scene prior to law enforcements arrival; however, deputies observed on single spent shell casing lying in the driveway.

Based on the above stated facts I have reason to believe and do believe the Defendant, Thomas Lee Findley, violated FSS 784.021.1b, This Offense occurred in Okaloosa County where I am a sworn Deputy Sheriff.
