[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Beginning on April 11, 2019, law enforcement investigators were conducting an operation targeting individuals seeking sexual encounter with children. A reverse advertisement was placed on Craigslist to not contact an email address because it was a thirteen (14) year old juvenile female trying to have sex with an adult.

On April 11, 2019, an individual using the email account graylatrell@yahoo.com contacted the undercover officer who was posing as a fourteen (14) year old juvenile female, in Okaloosa County, Florida. During the email conversations the undercover officer reestablished the age of the juvenile female as fourteen (14) years old. The unknown male using the email account of graylatrell@yahoo.com sent an email stating "You want some dick too" along with an image of a penis. The conversation moved from email to text message where the unknown male was using the telephone number 850-[REDACTED] During these conversations, which occurred from April 11, 2019, through May 1, 2019, between the unknown male and the undercover officer posing as a fourteen (14) year old juvenile female the male solicited what he

believed to be a juvenile female for sex three different times and sent a picture of his face as well as two additional penis images.

Public records checks of the phone number and email address revealed the person of interest in this case to be Dominique Latrell Gray DOB 5/10/1991.

In review of the face picture sent and public records on Dominique Latrell Gray Florida Driver's License revealed that the images were visually similar and lead your Affiant to believe that the picture sent and the Florida Driver's License is the same person.

On May 30, 2019, the honorable Judge Mason signed a search warrant for the email account graylatrell@yahoo.com. A review of the search warrant return for email address graylatrell@yahoo.com shows that the email address is linked to Dominique Latrell Gray. The date of birth on the account is the same as Gray's, 5/10/1991, and the associated phone number of 850- is the same phone number which was used to text with the undercover officer.

On August 14, 2019, a subpoena was issued by the State Attorney's Office of the First Judicial Circuit to the cell phone provider T-Mobile for information in reference to phone number 850-.

In review of the subpoena return from Verizon, in reference to phone number 850- the results showed that the phone number's subscriber name is Dominique Gray along with the address of Mobile, Alabama, 36603, which is a documented address in public records for Gray. In the call detail records associated with the subpoena return also observed were SMS messages exchanged between Gary and the UC number during the time the solicitations occurred.

Based on the aforementioned information I have reason to believe that Dominique Latrell Gray did violate Florida State Statutes 847.0135 (3a) Solicitation of a minor; 847.0135 (5b) Obscene communication to a minor and §34.215 Use of a two way communication device to commit a felony. This incident occurred in Okaloosa County Florida where your Affiant is a sworn Law Enforcement Officer.
