[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On March 15, 2020, at approximately 1817 hours, Terrence Rudder/DEFENDANT committed the offense(s) of Aggravated Assault Of A Law Enforcement Officer, Corruption By Threat Against Public Servant, and Resisting A Law Enforcement Officer With Violence.

On the above date and time, I investigated a reckless vehicle and possible traffic crash involving a white Chevy pickup truck and a tree, at 3 Lakeview Drive, Florosa, Florida. Dispatch relayed the suspect vehicle was observed pulling into the above residence driveway.

Upon arrival, I observed a white Chevy pickup truck bearing Florida tag #4815BQ in the driveway of 3 Lakeview Drive. I observed significant passenger side front bumper damage and significant damage to the vehicle's front passenger tire consistent with a traffic crash involving a tree.

I knocked on the door and heard a commotion from inside of the residence. I made contact with Barbara Rudder/OTHER PERSON at the front door. Barbara stated the vehicle belonged to her husband but he was not home. During this time I observed a white male with long hair and wearing no shirt, later identified as the DEFENDANT, walk behind Barbara. Barbara stated that was her friend, but would not provide a name for her friend. Shortly after, the Defendant approached the front door and began yelling obscenities with slurred speech to include, "Fuck you" and "You have no right here" while holding a rifle in a tactical, low ready position and taking a position of cover inside of a doorway. The DEFENDANT had his body squared off against me in the same posture I use when conducting target practice on the firing range. I ordered the DEFENDANT to put the weapon down. Instead of complying, he continued to yell at me, maintained his posture, and continued to offer to do violence. I feared the DEFENDANT would shoot me and I retreated to a position of cover behind a vehicle in the driveway. The DEFENDANT eventually exited the residence without any weapons, but continued to refuse to obey commands. After displaying my Taser, I was able to handcuff him.

I then spoke with Barbara who stated she stood in the doorway and lied to me because she was in fear of my safety. Barbara stated she saw the DEFENDANT grab the "gun" and did not know what was going to happen.

While in my patrol car, the DEFENDANT began to hit my patrol car window several times with his elbow, was removed from the vehicle, and placed on the ground to prevent property damage. During this process, the DEFENDANT threatened harm to the deputies restraining him by stating "I am going to blow your head off" and "I am going to kill all of you."

It should be noted that all Okaloosa County Deputies on scene were wearing a uniform that bore 2 patches and a badge that was visible at all times to the DEFENDANT, and clearly identified them as law enforcement officers during this incident.

Based upon the aforementioned facts and information, I have reason to believe and do believe Terrence Rudder/DEFENDANT did violate the following:

Florida State Statutes: 784.07.2c - Aggravated Assault Of A Law Enforcement Officer, 838.021.3b - Corruption By Threat Against Public Servant, and 843.01 - Resisting A Law Enforcement Officer With Violence.

This offense occurred in Okaloosa County, Florida, where I am a sworn Deputy Sheriff.
