- One (1) black sunglass case containing four (4) used syringes; One (1) glass pipe (FTP methamphetamine); Approximately nine (9) grams of suspected heroin (FTP); Approximately nine (9) grams of suspected methamphetamine (FTP); Approximately three (3) grams of suspected cocaine HCL (FTP); Eleven orange pills inscribed "AN/415" identified as Buprenorphine a schedule three controlled substance via pill identifier. This case was located at MEARNS' feet next to another glass smoking device (FTP methamphetamine).
- One (1) black and white coin purse containing approximately one (1) gram of suspected heroin; One (1) gram of suspected methamphetamine; One half of a green pill matching the above referenced Alprazolam pill; Unknown green leafy substance. The coin purse was located in between FOSTER's seat and the center console.
- One (1) black purse containing assorted drug paraphernalia was located inside a larger brown purse at FOSTER's feet.

Post Miranda, SULLIVAN requested an attorney, MEARNS denied ownership of the contraband advising it belonged to SULLIVAN, and FOSTER denied ownership advising SULLIVAN should claim possession.

Based on the above, your Affiant has probable cause to believe as Jessica Y. FOSTER violated Florida State Statutes 893.13.6a: Possession of Methamphetamine; 893.13.6a: Possession of Heroin; and 893.13.6a: Possession of Alprazolam.
