[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 15 at 18:38, I was traveling north on Brackin Street, approaching E. 1st Ave., in a marked patrol vehicle. I observed a white 2013 Hyundai 4dr, bearing FL-NAZA11, traveling westbound on First Street. It appeared that the vehicle was not going to stop at the stop sign on First Street, due to its speed. The driver saw me and quickly slammed on the brakes, but could not stop without part of the front end of the vehicle obstructing my lane of travel. I activated my lights and the vehicle stopped on Pine Ave.

The driver identified himself, verbally, as Craig L Calloway and he said he didn't have his driver's license on him. I asked him to step from the vehicle and I observed a brown leather gun holster clipped to his driver's side door. I also requested the female occupant, Stephanie Richelle Davis, to step from the vehicle after my observation. Both said they were convicted felons. I then requested backup and checked both in MNI, FCIC and NCIC. I observed Calloway to have alerts for Convicted Felon, Violent, Burglar, and have a FDLE DNA profile, according to MNI.

D/S Sgt. Hehl arrived on scene and immediately observed a live round of handgun ammunition, in plain view, in the center console tray. Calloway was immediately detained.

A search of the vehicle was conducted by Sgt. Hehl and D/S Dowdy. Sgt. Hehl found 14 small plastic zip-lock jewelry bags, commonly used for packaging illegal drugs, in the center console tray. He also located 3 inert 9mm handgun training rounds and one spent 9mm shell casing under the stereo on the center console. Sgt. Hehl further located a baggie containing brown powder, a baggie containing a white/clear crystalline substance, 1 and half orange pills identified as Buprenorphine HCL 8mg (Schedule III-Prescription required) and a digital scale inside a black "Batman" zip-up case. The brown powder tested presumptive positive as heroin (less than 1 gram weight inside baggie) and the crystalline substance tested presumptive positive as methamphetamine (4 grams weight inside baggie). Sgt. Hehl also located Calloway's DL in the center console near the live 9mm round. Located in the trunk was a document in a red bag dated January 2020, belonging to Calloway.

D/S Dowdy located a blue drawstring bag on the front passenger floorboard that contained a 9mm handgun identified as an IWI Jericho 941, serial [REDACTED]. The gun was loaded with five 9mm rounds in the magazine. There was also 4 live 9mm rounds and one snap cap, identical to the ones found by Sgt. Hehl.

Davis was read her Miranda Warning and stated she understood her rights. She agreed to speak with deputies and gave a sworn video statement advising that she had no knowledge of the gun, but knew Calloway was a drug dealer. She stated they have "been together" 10 years. She said he had just picked her up and the blue bag containing the contraband was already in the car when she got in. She said he was the primary operator of the vehicle and the documents found in the vehicle corroborated this statement.

A criminal history was obtained on Calloway which showed he had 27 prior felony convictions including an arrest on 6/14/2017 by Miami Springs Police Department for Possession of a Weapon by a Felon with a guilty verdict on 8/19/2019.

I do believe and attest Calloway violated Florida State Statutes:
