[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 05, 2020, your AFFIANT observed a red 2007 Ford Mustang, bearing Florida registration #326QFH, traveling northbound on N. Ferdon Boulevard, Crestview, Florida. Your AFFIANT conducted a registration check on the vehicle

through the DHSMV, which indicated the registration plate, that was currently displayed, was registered to a silver 2019 Nissan.

Your AFFIANT turned northbound onto Georgia Street, behind the Ford. At that time, the Ford accelerated rapidly in an obvious attempt to evade your AFFIANT. Your AFFIANT activated his emergency lights in an attempt to conduct a traffic stop on the Ford. The Ford turned westbound onto 4th Avenue and accelerated rapidly, again. As the Ford approached the intersection of 4th Avenue and Anderson Street, the Ford failed to stop at the stop sign at that intersection. The Ford continued traveling westbound, crossing Anderson Street, and striking a chain link fence. The Ford came to a final stop in the empty field, west of Anderson Street.

Your AFFIANT observed the DEFENDANT, Coshua BONNER, exit the driver's compartment of the vehicle and flee northbound on foot, towards North Avenue. As the DEFENDANT climbed over a chain link fence, on the north side of the field, the DEFENDANT dropped several items, to include a pink zip-up case. The DEFENDANT was challenged as he fell at the base of the fence and he was apprehended.

The pink bag was searched, post arrest, and was found to contain the following:

- Seventeen (17) grams of methamphetamine
- Four (4) grams of heroin
- Two (2) grams of heroin
- Two (2) grams of crack cocaine
- Two (2) grams of fentanyl
- Four (4) bags of marijuana, totaling twenty-six (26) grams
- Digital scale

On the driver's side rear floorboard of the vehicle, your AFFIANT observed a silver Jennings 9MM handgun. The handgun was later found to contain four (4) rounds of 9MM luger ammunition.

A criminal history was requested on the DEFENDANT. On August 07, 2018, the DEFENDANT was arrested for Possession of a firearm by a convicted felon. On December 11, 2018, the DEFENDANT was convicted of the charge related to that investigation. The DEFENDANT also had ten (10) additional felony convictions.

There is probable cause to believe, and your AFFIANT does believe, Coshua BONNER, knowingly violated Florida State Statutes 790.23.1a; Possession of a firearm by a convicted felon, 893.135.1f1; Trafficking methamphetamine, 893.135.1c1; Trafficking heroin, 893.13.6a; Possession of crack cocaine, 893.13.7a4; Marijuana distribution, 893.13.6a; Possession of fentanyl, 316.1935.2; Fleeing and eluding, 843.02; Resisting arrest without violence, and 893.147.1; Possession of drug paraphernalia.

This incident did occur within Okaloosa County, Florida, where your AFFIANT is a sworn Law Enforcement Officer.
