[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 25, 2020, the DEFENDANT, Maria Jaimicia Llaría Rodriguez Barnes, DOB 04/26/1989, committed the offense of 1st Degree Murder pursuant to F.S.S. 782.04. This offense occurred in a 2005 Nissan Titan truck bearing Florida license plate #0989PV while parked in the parking lot of The Boardwalk located at 1450 Miracle Strip Parkway, Fort Walton Beach, Okaloosa County, Florida.

The DEFENDANT shot her son, the VICTIM, Jaxxon Gunner Rodriguez Barnes (5 month old), one time, in the chest causing his death. The DEFENDANT then shot herself, one time, just below her left breast in attempt to commit suicide.

WITNESS, [REDACTED], observed the Defendant lying on the ground, rolling from side-to-side in what appeared to be blood. The WITNESS called 911, lifted the DEFENDANT'S shirt and saw blood on her chest as well as a wound on her back. The WITNESS did not see anyone else enter or exit the vehicle. Video footage from a nearby business corroborates the WITNESS' statement.

Upon OCSO deputies' arrival, the DEFENDANT was observed to have a bullet hole in her left bra cup. The DEFENDANT denied being shot or assaulted and continuously advised she could not breathe. Deputy Burnham asked the

DEFENDANT if someone shot her and she stated no. Deputy Burnham then asked the DEFENDANT "what happened". The DEFENDANT replied by saying "I can't breathe". While attempting to locate the firearm, OCSO deputies discovered the VICTIM on the left rear floorboard of the DEFENDANT'S Nissan truck. It should be noted the DEFENDANT was still on scene at the time the VICTIM was located and she never said anything about the VICTIM who is her 5 month son. The VICTIM was in a seated position, slightly slumped over, on a pillow. The VICTIM was pronounced deceased by Okaloosa Island Fire Department Captain Mike Simmons at 0840 hours. A black firearm was observed, in plain view, on the rear floorboard of the truck.

On March 25, 2020, a search warrant for the truck was completed and signed by the Honorable Judge John Brown and later executed on said truck. A black Glock (Model 17 Gen 4) 9mm caliber firearm, two Luger Hornady 9mm fired cartridge casings, two projectiles, and a handwritten note was located inside the truck. The handwritten note included instructions on where to locate additional documents and other "needed information". The note also stated "I'm [REDACTED] The note had the name "LaKeisha now Maria" written on it.

During this investigation, it was learned the DEFENDANT sent an email to [REDACTED] on March 25, 2020, at 0730 hours. The email included the following statements: "I know this is a permanent solution to a temporary problem but it's my choice" and [REDACTED]

The investigation also revealed the DEFENDANT sent a text message to [REDACTED] This message was sent on March 25, 2020 at 0730 hours. The message included the following statements: [REDACTED]

On March 26, 2020, an autopsy was conducted on VICTIM, Jaxxon Gunner Rodriguez Barnes', body at which time Doctor Timothy Gallagher advised he observed a gunshot wound on the left side of Jaxxon's chest. According to Doctor Gallagher, the gunshot wound he observed is the cause of death and the manner of death is homicide by gunshot.

Based on the above information, I have reason to believe and do believe the DEFENDANT, Maria Jaimicia Llarra Rodriguez Barnes, committed the offense of 1st Degree Murder in violation of F.S.S. 782.04. This offense occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.
