[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 5-14-20, I was contacted by [REDACTED] at 1450 Miracle Strip Parkway, Fort Walton Beach Florida in reference to a Domestic Battery.

My investigation revealed that the victim [REDACTED], who provided a sworn statement, was battered by her boyfriend Kalen Branson, at their residence located at [REDACTED] Fort Walton Beach Florida. The victim and defendant have resided together for approximately ten months and are currently in a romantic relationship. [REDACTED] stated that she was pushed to the ground, and punched in the face by Kalen's fist, causing a swollen and bruised eye. [REDACTED] further stated that Kalen ripped her earring from her left earlobe, causing a laceration that required medical treatment and approximately 9 stitches. The injury caused permanent disfigurement to her right ear lobe.

Post-Miranda warning, the defendant denied any altercation took place.

While interviewing the defendant, I was able to see what appeared to be fresh blood on a bed sheet where the victim stated the battery occurred, in plain view.

This is in violation of F.S.S 784.045(1a1) (Aggravated Battery/Domestic Violence) and did occur in Okaloosa County Florida.


