[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On May 14, 2020, Michael Anthony White, DEFENDANT, committed the offense of Florida State Statute

784.045.7A1: Aggravated Battery with a Deadly Weapon; 784.021.1a: Aggravated Assault with a Deadly Weapon; 790.23: Possession of Firearm or Ammunition by a Convicted Felon. This offense occurred at 5359 Woodland Street, Crestview, Okaloosa County, Florida.

On May 13, 2020, the Victim, Danny Mason, was parked in his white 1999 Chevrolet bearing Florida registration Z00IRQ in front of the Defendants residence of 5359 Woodland Street, Crestview, Okaloosa County, Florida. The Victim had fallen asleep, in his Chevrolet, after assisting the Defendant with repairs on the Defendants motorcycle, shortly after 2200 hours.

On May 14, 2020, the Victim was awoken by the Defendant, who began striking the Victim in the face with a black semi-automatic handgun. The Victim was then pulled from the Chevrolet by the Defendant, who then began to kick the Victim multiple times in the head and neck area. The Victim was able to get into his Chevrolet and began to flee as the Defendant fired the handgun towards the Victim from the Defendant's porch. The Victim advised the Defendant was agitated over a failed narcotics transaction earlier, on May 13, 2020, whereas the Victim was the middle man.

As the Victim fled the residence, the Defendant and Co-Defendant, Jared McCowen, gave chase in the Co-Defendants red 2007 Ford bearing Florida registration JFMH20. During the pursuit, the Co-Defendant fired multiple rounds at the Victim in the area of Hare Street, Crestview, Okaloosa County, Florida. During this chase, the Victim notified Okaloosa County Sheriff's Office to report the active incident. Subsequently, multiple Law Enforcement Units responded and located the Victim's vehicle, followed by the Defendant and Co-Defendant.

The victim sustained a sizeable deep laceration to his right eyebrow and his shirt had been ripped due to the incident.

Okaloosa County Sheriff's Office Deputies attempted to conduct a traffic stop on the Defendant and Co-Defendant who were located actively pursuing the victim. The Ford failed to stop for Law Enforcement who were operating marked patrol vehicles with Emergency lights and sirens activated. The Ford continued onto Highway 90 from Highway 85 Westbound for 3.2 miles, turning Southbound onto Antioch Road. The Ford traveled 1.19 miles then turning East onto GMC Lane, Crestview. Once onto GMC Lane, the Co-Defendant exited the front left driver's seat and fled the location on foot.

The Defendant remained seated within the front right passenger seat of the Ford and was subsequently taken into custody and read his Miranda Rights from a prepared text.

Post Miranda, the Defendant advised he woke up for work at 0530 hours and walked outside to find the Co-Defendant parked in his driveway. Upon entering the Ford, the Co-Defendant told the Defendant the Victim was in his Chevrolet. As the Victim left the residence, they followed, due to the Victim owing the Co-Defendant money. Once on Hare Street, the Co-Defendant began to fire a gun at the Victim. Shortly after, the Co-Defendant failed to stop for Law Enforcement, and a pursuit ensued, which ended at GMC Lane, where the Co-Defendant fled the scene.

During treatment at the North Okaloosa Medical Center for an unrelated medical issue, the Defendant told on scene Deputies he was going to give them a reason to take him (Defendant) to jail. The Defendant began to resist Law Enforcements commands and efforts to restrain him by continuously pulling away until Law Enforcement was able to physically control the Defendant.

A search warrant was read and signed by the Honorable Judge Michael Flowers for the residence of the Defendant, 5359 Woodlands Street, Crestview, Okaloosa County, Florida. During the execution, two (2) 9mm rounds located on the Defendants nightstand in the Defendants room. A Criminal History query revealed the Defendant as a convicted felon as of 12/03/2014.

This offense occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.
