[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 5/18/2020 at 0000 hours, I attempted to conduct a traffic stop of a Gray Honda Civic bearing license plate Z19FET, in which Samantha Mariah FRAZIER (Defendant) was the driver and sole occupant, after observing the vehicle traveling eastbound on Lovejoy Road with no lights on during the hours of darkness.

Upon observing the traffic infraction, I positioned my marked OCSO patrol vehicle behind the Honda Civic. The Honda Civic was traveling in a southbound direction on Mary Esther Boulevard just in front of 521 Mary Esther Boulevard when I activated the emergency lights on my patrol vehicle in order to conduct a traffic stop.

The Honda Civic began to slow, however, continued forward motion. I activated the siren installed in the marked patrol car to gain the attention of the operator of the Honda Civic. The Honda Civic then rapidly accelerated away from me and began making evasive maneuvers to include lane changes and cutting in front of another Deputy Sheriff operating a marked OCSO patrol vehicle with blue lights activated. The Honda Civic continued southbound on Mary Esther Blvd. until reaching the intersection of US HWY 98 where it failed to stop for a solid red light displayed on the traffic control device located at this intersection. The vehicle then failed to negotiate a left turn on to US HWY 98 due to its excessive speed, left the roadway, and collided with the residence located at 101 Point Comfort Road where it caused significant damage to the west-side outer brick wall of the residence. Frazier then exited the vehicle where she was taken into custody by Deputies.

During a post Miranda interview Frazier stated she removed the license plate from her sister's vehicle and placed it on the Honda Civic without the sister's knowledge. It was also discovered Frazier's driver's license was listed as suspended with notice provided on 05/08/2019. This was confirmed via FCIC/NCIC and D.A.V.L.D. query. The approximate distance of the attempt to elude law enforcement was approximately 6,072 feet. This distance was obtained using www.googlemaps.com.

Due to the above, I believe Frazier violated Florida State Statutes 316.1935.3A: Fleeing/Eluding Police with Disregard of Safety to Persons or Property, 320.261: Attaching Registration License Plate Not Assigned, and 322.34.10.B.1.: Knowingly Drive while License Suspended or Revoked.

This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
