[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Deputy Sheriff Gabriel Roberson, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since September 2019. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant previously served as a Patrol Officer with the Fort Walton Beach Police Department (FWBPD) for two (2) years and as a Deputy Sheriff for one (1) year with the Santa Rosa County Sheriff's Office (SRCO). Your Affiant being duly sworn states as follows:

On 05/22/20, at approximately 1140 hours, a passing motorist observed a small child walking across US Highway 98. Your Affiant responded to the intersection of US Highway 98 and Parish Avenue, Florosa, Okaloosa County, and took custody of the male child, who appeared to be approximately 2 years of age. The child was wearing a diaper only.

Based upon knowledge of young children at [REDACTED] and multiple calls for service at that location, your Affiant attempted contact with the residents of the aforementioned location.

Upon approach, your Affiant observed both the garage door and the interior door of the residence to be open. After announcing their presence several times, your Affiant made contact with Micah ADKINS (Defendant). The Defendant positively identified the child as [REDACTED]

Both pre and post Miranda, the Defendant stated he had placed the Victim in [REDACTED] bed, left the room, and began checking emails in an adjacent room. The Defendant did not hear the Victim open the bedroom door, nor

did he hear the Victim open the interior door to the garage. The Defendant surmised the Victim got out of the bed, walked down the hallway and to the door of the garage. The Victim disengaged the only lock on the door (latch at the bottom of the door) and walked through the open garage and into US Highway 98.

The Defendant stated it was the second time the Victim has done so in the past three days. The first incident occurred on either 05/19/20 or 05/20/20, when the Defendant left the Victim and [REDACTED] (Witness) alone in the residence, while he walked to the convenience store down the road. The Defendant found the Victim in the parking lot of a car wash directly adjacent to his residence.

Since the first incident of the Victim leaving the house, the Suspect did not take any precautionary measures to secure the entire residence from the Victim's attempts to leave the residence. The Defendant left the garage door open and unsecured, and the lock on the interior door was in such a location that the Victim easily disengaged it and exited the residence.

Based upon the physical evidence, the Suspect's statements, and the Suspect's culpable negligence, your Affiant has reason to believe and does believe the Suspect violated F.S.S 827.03(2d)-Child neglect.
